



END OF FINANCIAL YEAR CONTRIBUTIONS TO SUPER

The End of Financial year is rapidly nearing. If your income is less than \$31,920 pa, you may be eligible for the full \$1,000 government co-contribution if you contribute \$1,000 before June 30 this year. If you earn between \$31,920 and \$61,000 you may still be eligible for a part co-contribution.

If you wish to take advantage of this government incentive to contribute to super, you will need to have your cheques in to us no later than Friday 22nd June to allow your fund time for processing. If you wish to contribute by BPay or EFT, please contact our office by this date to obtain the BPay or EFT details and reference number for your funds.
